**May 26** – Guest Teacher Rachael Candee will present the meditation. The Transition Team has been busy working under Rev Issac Lawson's leadership at the SNEUCC Conference Office. There are two documents which the Transition Team has been working very diligently on and have found quite challenging: The Local Church Profile for Churches Seeking an Interim Pastor and Congregational Opportunity Form. Both of these documents have been completed and have been submitted to SNEUCC conference office. The next step is for them to be reviewed and posted to the National UCC ministerial opportunities web site for any minister to review and if a discernment is felt, to submit their profile to the Transition Team for consideration.

The next step: When an intentional interim minister has been identified and on board, the intentional interim minister will provide worship leadership on Sunday morning as well as guiding the Transition Team in the development of a church profile (approximately 22 pages long). When the Church Profile has been sent to the SNEUCC conference office, the steps outlined in our church bylaws will be followed to form a Search and Call Committee. Their responsibility will be to review and interview potential candidates responding to the Church Profile. The Transition Team will dissolve when the intentional interim pastor leaves anda settled pastor is called.

To reach this point in the search and call process has been challenging and yes, frustrating as there have been times when the process seemed to be at a complete stand-still. Still moving, but seeming to just be so slow. However, utilizing our team's resources and assets, we looked at what needed doing and we have kept moving forward. The one simple facet which has kept us moving forward is knowing we are NOT doing this alone, that God is with us, guiding us as we move forward - He has been by our side, traveling with us, encouraging us. We are not alone on this journey. This journey has not been a lonely journey as it is a journey with God by our side – always by our side.

## Organ Repair Fund

It has come to my attention through playing the organ and consulting with the Foley Baker Organ Company that our Moeller Pipe Organ needs major repair. The pneumatic system inside the console needs to be repaired. Because of wear and tear, some of the stops do not play as required. Our instrument, which is valued at over a million dollars, needs work done at an estimate of \$32,165.00.

The Trustees have approved an organ repair fund, and a line item has been created in our budget. The organ company cannot do the work until next year, so we have time to begin raising funds.

I am always optimistic, and I am sure we will find a way to take care of this beautiful instrument which has served the church since 1963.

## Being Thankful



If you were not in attendance for the Sunday morning worship service on April 21 to hear Cathy Johnson and her Message for All on prayer, may I suggest/recommend you take a moment to go to <u>our YouTube channel</u> and listen to her message.

Her message has had me thinking about prayer – not so much as a petition to the Lord for intersection, but to be

thankful for my/our blessings. I am sure you have heard this line sometime from Psalm 107:1 -

#### Give thanks to the Lord, for He is good; His love endures forever.

According to some of the things I have read and heard, people who are intentionally grateful for what they have report better sleep, fewer symptoms of illness, and overall more happiness. Those are impressive benefits! Have you ever considered keeping a "gratitude journal", writing down five (5) things you are grateful for each week?

If you are a biblical scholar, you already know scripture has long promoted the practice of gratitude. From meals and marriage (1 Timothy 4:3-5) to the beauties of creation (Psalm 104), the Bible has called us to see such things as gifts and to thank the Lord for them. Psalm 107 lists five things Israel could be especially grateful for: their rescue from the desert (vv 4-9), their release from captivity (vv 10-16), healing from disease (vv 18-22), safety at sea (vv 23-32), and their flourishing in a barren land (vv 33-42). And, hear these words: "give thanks to the Lord" the psalm repeats, for these are all signs of God's "unfailing love" (vv 8, 15, 21, and 31).

Why not stop and get a notepad or even use the back of an envelope and write down five (5) things you are grateful for right now? Let me make a few suggestions to get you started: how about the meal you just enjoyed, or maybe something positive which has happened in your life, or as you are sitting there thinking, do you hear the birds singing outside, or how about the comfort of your dwelling, or gratitude for the loved ones in your life?

Stop and reflect on these suggestions or even more unlisted things you can be grateful for. Each is a GIFT and a SIGN of God's unfailing love. In your prayers, be sure to thank the Lord for ALL your gifts.

## Trustees

#### BOARD OF TRUSTEES

Per our Bylaws, the Trustees are entrusted with, among other things, "...the care and custody of the property of the church and have charge of its financial affairs."

We encourage members of the various church committees and boards (as well as all church members) to have available at their meetings, copies of the Bylaws and Procedures Guidelines for reference purposes. They come in handy for planning events that you or your group may want to sponsor or have general operational questions or need clarifications.

When submitting a request to the Trustees, we ask that the following procedures be followed:

- Send an email or written letter (this can be placed in the Trustee box outside of the church office) to the Trustees (current members are Cathy Johnson, Phyllis Meyer, Bonnie Geisler, Richard Stottlemyer, and Sue Blaisdell). Email addresses can be found in the Church Directory.
- In the subject line, please indicate the group or committee name that the request is coming from (e.g., Women's Fellowship, Deacons, Missions, etc.).
- In the body of the email or letter, describe what it is that is being sought (use of Dutton Hall, permission to raise funds and for whom, use of outside property, etc.). Provide as much information as possible. Use of the sanctuary falls under the purview of the Deacons.
- State the date or time period at issue. If the request involves use of the building, check with the church office to see if there is anything on the calendar for that date. If the request is not of an urgent nature, the Trustees will address it at their next meeting (first Sunday of the month, after service, or as needed). If an immediate response is needed, the Trustees will address accordingly.

Regarding placement of signs on the church lawn: as it came to our attention a few years ago, since we are located in a historic district of the City, there is a zoning ordinance regarding the length of time that we can have signs on our lawn. If a church committee would like to advertise an event (or promote some type of church-related matter) by use of signs on our lawn, they must first seek permission of the Trustees, using the procedure described above. Once the request is granted, Connie Stoddard has agreed to be our point-person with the City in terms of contact and obtaining permission. Thank you, Connie!

"Property", as used in the Bylaws, comes in many forms, not just the physical. Property includes the church's website and Facebook Page (social media). These are, in essence, a virtual door to our church and contribute to a first and lasting impression. We want to be sure we are following all legal and media rules.

The Trustees have appointed Sue Blaisdell as our website administrator; this decision was made based on her education and experience in the field.

Sue is in the process of updating the website; it is a work-in-progress. Due to the volume of requests and suggestions being made, a new email address has been established through which inquiries, suggestions and photographs can be sent: webmaster@grotoncongregational.org (continued next page)

(please do not use Sue's personal email address for website-related matters). Please keep in mind that some photographs may be deemed not suitable based on quality or applicable subject matter. Any individuals in the proposed photographs must have signed a media consent release form; these forms can be found on the table in the Midway and should be submitted to the office. Any requests for updates that are outside of necessary and custom revisions should be forwarded to the Trustees for consideration.

It is important that all content uploaded to the website be in keeping with the image that we want to present as a faith-based community.

In a similar regard, the Trustees voted to remove the church's use of and affiliation with X/ Twitter. This decision was based on antisemitic comments by its owner and the support of pro-Nazi posts. We felt that this particular networking site does not align with our church and faith values. The account has been deactivated.

Recently you heard from Sue Stottlemyer regarding the need for expensive organ repairs. As relayed, the Trustees approved her request for the establishment of a fund for the collection of donations towards the repairs. Be on the lookout for special donation envelopes or use your own!

As you may or may not know, I (Cathy Johnson) was the representative of Groton Congregational for the Groton Bank Day, Inc. organization. For the past few years, its main focus was promoting the Groton Bank area. One of the major events it undertook was planning and managing Groton Heights Open House Day (in conjunction with CT Open House Day, which has been, and continues to be, held yearly in June). Funds raised to conduct the event went toward shuttle buses, informational flyers, banners, marketing, etc. The other member organizations were Avery -Copp Museum, Avery Memorial Association (Ebenezer Avery House), Bill Memorial Library of Groton and Fort Griswold Battlefield State Park Foundation, Inc.

About a year ago, the difficult decision was made to disband the organization. As part of the dissolution process, any remaining funds were to be evenly distributed among the member organizations. As Groton Congregational was a member, it received a check in the amount of \$639.82. The Trustees voted that these funds go to the newly created Organ Repair Fund.

If you go to the church's website (grotonucc.org) you'll see, in the upper, right-hand corner, a "Give" button. When that button is clicked on, a viewer will be directed to a page where they can donate using PayPal or with a debit or credit card and, once an amount and method of payment is inserted, the donor will be given the option of submitting a note/directive of where (what fund) they would like their donation to be applied to.

In addition to the Organ Repair Fund envelopes, there is another envelope located in the pew backs and into which donations can be specified. If money in the collection plate is not somehow marked for a specific fund, then it will go into the General Fund – there is no other way for the Treasurer to know the donor's intent. Thank you for your continued support of the various areas within our church family.

Due to a resignation and the death of Barbara Dutton, the Trustees have two vacancies on the board. If you would like to suggest someone, please let Bill Blaisdell (Nominating) know.





#### **SNEUCC Sends Letter Supporting Healthcare Bill**



The Director for Human Resources for the Southern New England Conference recently sent a letter to Connecticut legislators in support of a proposed bill requiring all workplaces, regardless of the size of the organization, to offer paid sick time to employees.

"The Southern New England Conference, United Church of Christ recognizes the benefits of expanding paid time off. We believe it allows our organization a greater opportunity to support staff when they are affected by an illness of any kind, and more significantly,

pay them for the time they are out sick," Irma Reyes, Director for Human Resources and Staff Engagement, wrote in the letter.

"As a faith-based, non-profit organization, also known as a 'religious organization' located in three states, Connecticut, Massachusetts, and Rhode Island, we are exempt from some of the normal employment laws applicable to other non-religious organizations. In perspective, as with the Federal Family Medical Leave Act, it is within our beliefs and values we implement a policy to comply with said law, under the same eligibility and qualifications of the program. To say this is to acknowledge that while voluntary, this is one way our organization considers all avenues, to protect the employment of our staff," she wrote.

"From my perspective, as the Director of Human Resources and Staff Engagement, we indeed care about staff work and productivity, and more critically, we trust the most productive and effective work is done when staff are healthy and well," she wrote.

Executive Conference Minister the Rev. Darrell Goodwin <u>recently conducted a video</u> <u>interview</u> with State Sen. Julie Kushner (D-Danbury) and State Rep. Manny Sanchez (D -New Britain), cochairs of the Labor Committee. The two lawmakers talked about the importance of the bill, as currently only companies with more than 50 employees are required to offer paid sick time.

Goodwin asked them how churches could show support, and they encouraged churches to write emails to their legislators in support of the bill, and also said it would be helpful for churches that offer paid sick time to explain why they prioritize that even when not legally required to offer it.

He is encouraging churches to write their own letters, and invited them to use the letter from Reyes as a model. (Read the letter on the next page..)

Dear Senator Kushner,

Thank you for the urgency in your proposed bill requiring workplaces to offer employees 40- hours of paid sick time per year and expanding mandates to include all employers regardless of the size of their organization.

The Southern New England Conference, United Church of Christ recognizes the benefits of expanding paid time off. We believe it allows our organization a greater opportunity to support staff when they are affected by an illness of any kind, and more significantly, pay them for the time they are out sick.

As a faith-based, non-profit organization, also known as a "religious organization" located in three states, Connecticut, Massachusetts, and Rhode Island, we are exempt from some of the normal employment laws applicable to other non-religious organizations. In perspective, as with the Federal Family Medical Leave Act, it is within our beliefs and values we implement a policy to comply with said law, under the same eligibility and qualifications of the program. To say this is to acknowledge that while voluntary, this is one way our organization considers all avenues, to protect the employment of our staff.

Today, we are comforted by the continued support of our Executive Conference Minister, Rev. Darrell Goodwin, who unequivocally and intentionally prioritizes the health and well-being of all staff.

From my perspective, as the Director of Human Resources and Staff Engagement, we indeed care about staff work and productivity, and more critically, we trust the most productive and effective work is done when staff are healthy and well. In fact, "Health and Well-being" is one of the components of our Performance Management program, creating space to ensure staff sets time aside for their physical and mental wellbeing.


The Southern New England Conference, while unique to others, understands the importance of retaining our dedicated staff, and encourages staff to take time off when they are sick, so they may take care of themselves or their family members.

We want to keep our committed and exemplary staff on board; hence, the proposed mandatory requirement to expand our paid sick leave hours is necessary, and issuing requirements, by law, to expand our sick time off makes it essential to embed them into our normal paid sick leave policies.


